Mr. Dennis was responsible for the design, development, and subsequent United States patent of the FIRST dimensional hair color application Adhesive Highlighting Strip for the professional Beauty Barber industry, known as; Lightworks® Adhesive Highlighting Strips. This product is for use with dimensional hair color applications known as highlighting. A five-year Master Distributor agreement for the patented strips was negotiated by Mr. Dennis and entered into between Kimberly Clark® Corporation and his company, Lightworks® International, Inc., and Lightworks International Trust. Mr. Dennis, as Founder, Chairman/CEO/President worked together with his team of industry professionals to create and develop an international sales and distribution network.

Four months after the product's introduction, the sales and distribution negotiated by Mr. Dennis for Lightworks, achieved distribution in 24 countries and secured 360 distributors with more than \$18,000,000.00 in delivered sales. Lightworks had ongoing delivered monthly sales of \$2.2 million. Lightworks® "TNT" (Technical Network Team) Professionals, along with Lightworks distributor sales support and training personnel, traveled worldwide educating and training cosmetologists and Color Masters on the use of their patented highlighting strips.

Mr. Dennis and his team of professionals designed, created and manufactured one of the industries finest "***professional-only***" (meaning; *sold only in professional Beauty Salons and Day Spas*), all natural Botanical Hair Care product line, known as the Lightworks® Botanical Collection™ (also known in the industry as a "wetline"). The wetline consisted in-part, of shampoos, conditioners, treatments, leave-in conditioners, firm to light hold hair sprays, spritz', and styling gels, all ranging in product sku sizes from half-ounce sample size pillow-packs, to liters, and gallons.

The wetline introduced the industry's first complete line of botanical color conditioners covering the full color spectrum. Further, the wetline was the first distributed in all clear/crystalline recycled bottles. All products were biodegradable and packaged in recycled containers, boxes, etc., with all the company's marketing collateral produced on recycled paper and printed with soy-based inks. Lightworks® International, Inc. was a concerned GREEN Certified and environment-friendly company, located in Greenwood Village, Colorado.

Prior to Mr. Dennis selling his equity stake in Lightworks® in 1994 and during his tenure, he and his staff visited with many thousands of beauty industry professionals, in hundreds of salon and Day Spa businesses around the world. In addition, Mr. Dennis met, consulted with, and even co-brand marketed products with many of the industry's top manufacturers and distributors, such as, Wella® Corp., Clairol®, Kimberly Clark® and others. It is this experience and unique knowledge that Mr. Dennis has applied in establishing Ferris-Haggarty Mining Corporation.

Mr. Dennis was co-responsible for the advancement and associate development of Legacy Security®, Inc.(LSI), with Mr. Jon Alley, Founder, and President. Mr. Dennis reorganized LSI and in association with Mr. Alley, drove LSI to be the number one (#1) Authorized ADT® Security Systems Dealer in the United States within its' market sector. The company later reorganized and became ENET® Security Systems, and eventually became A-Link Security, which purchased its' own monitoring station, created and developed its' own national Dealer Network with their headquarters located in Houston, Texas. It is a national security company today with hundreds of distributors and millions of customers.

Mr. Dennis successfully negotiated numerous contract funding and factoring agreements. One of which, was a \$25 Million dollars a month / \$300 Million annually with DMAC Financial, a division of LaSalle® National Bank in Chicago, Illinois. DMAC Financial purchased the income streams from the company's sale of monthly security monitoring agreements. ENET®, then A-Link Security went on to attain sales of more than \$30 Million dollars a month in security system monitoring contracts and established offices and dealers nationwide. Mr. Dennis sold his equity interest and resigned as one of its' founding members and its Chief Operating Officer. He remained on the Board of Directors and as an adviser and consultant for another year.

Mr. Dennis has been responsible for the development and introduction of the first, patented Tooth-Desensitizing, Professional Dentist Grade Tooth Whitening system for sale through professional Beauty Salons and Day Spas. This product was sold throughout North American direct to Salons and Day Spas, including Elizabeth Arden Red Door Day Spa Salons. Thousands of units were sold daily via their website and Internet marketing efforts. Marketing to the industry was preformed through industry trade publications, direct mail marketing campaigns and cold calling by sales consultants and product educators. The company was later sold to his business partner.

Mr. Dennis was further responsible for developing the first In-line Street-Hockey Backpack for the carrying of all of one's street-hockey gear and equipment. His efforts lead him to negotiate and become the exclusive designer and manufacturer for all of LA Gear's® Men's, Women's, Girl's, and Boy's sport backpacks.

Mr. Dennis and the management team being assembled have a number of years' experience in multi-office/branch business administration, management, international and domestic marketing, manufacturing, international distribution, and importation. Retail consumer product design and

development, patent application processes with patents issued, along with international business management and complex business infrastructure and organization. Mr. Dennis has been part of, developed, orchestrated and initiated numerous S.E.C. security registration exempt; 504, 505 and 506 Reg. "D" and "A" private placements for the sale of equity shares of corporate stock, and worked with public offers raising working capital for corporate startups, acquisitions, and corporate expansions. His last exempt corporate Private Placement of corporate stock raised more than \$1.4 Million dollars in 10 months working strictly with Accredited Investors.

Mr. Dennis is also the Founder, President and General Manager for CG VII Real Estate and investments, LLC, a Colorado based real estate investment and acquisitions company.
